### Other Fees and Terms, DKK

Bus Fee per year (Only for K - 5)	The school assists with organizing a school bus using a private bus company. The cost depends on the distance and travel time from the school. The cost is fully payable by the users. The price for a distance of less than 10 km will cost DKK 39,600 per year and a distance of 10 – 20 km will cost DKK 42,900 per year. The bus service is booked for the school year and with 3 month’s notice. Invoicing is flexible and can be done in 10 instalments or one annual instalment.								
English as an Additional Language (EAL)	A separate fee may be charged to students whom are lacking English proficiency skills. The fee will depend on the amount of extra teaching required.								
Learning support fees	<p>Learning support fees are in addition to regular tuition and school expenses for students at each grade level. After School Club (K - 5)	<p><b>K-Grade 5:</b></p> <p>Occasional day: 140 DKK</p> <p>Every day: 1,730 DKK</p>
Extra IBDP Language	IBDP externally taught language. If the school is responsible for providing the teacher for language B the cost with 2 lessons a week will be about DKK 42,000 a year. This may vary depending on the level (SL/HL or B or A2).
Lost student card	Student cards will be invoiced at a rate of DKK 300 if needed to be re-issued more than one time during the school year.

## Other Fees and Terms, DKK (continued)

CPR Number Fee	DKK 45,000 (PYP K – MYP 5)	Extra fee for students enrolled at CIS before September 5 but <i>without</i> a CPR number and for whom the school therefore does not receive a state subsidy. Also applicable if the student lives in Sweden, except grades 11-12.
TUITION FEE	<p>Payable by May 6<sup>th</sup>. 2019 for the School Year starting in August.</p> <p>You can choose to pay Tuition in:</p> <ul style="list-style-type: none"> <li>a) One amount for whole year (whereby administration fee is saved),</li> <li>b) 8 installments– first installment due in May covers 3 Month tuition(3/10 of yearly tuition) , and then monthly installments in August, September, October, November, December, January and February each 1/10 of the yearly tuition</li> <li>c) Quarterly installments- first installment due in May covers 25% of yearly tuition, and additional installment of 25% in August, November and February.</li> </ul>	
LATE PAYMENT	If payment is late, a reminder will be sent out. Every reminder has a cost of DKK 125.	

<p><b>SUBSIDY, Pre-Kindergarten</b></p>	<p>Students attending Pre-Kindergarten may be eligible for a subsidy from the municipality (Danish: “Kommune”) in which they live. Please contact your local Municipality to apply for “privat børnepasning” subsidy.</p>
<p><b>SFO FEE</b></p>	<p>SFO is a Danish term that covers all after school activities for Kindergarten to Grade 3 and private schools in Denmark get a subsidy from the government for this. As these activities normally take place after school in Danish schools, not all children in a Danish school will attend the SFO and the subsidy is adjusted accordingly. At CIS such activities are integrated into the school day. Therefore CIS receives the SFO subsidy for all children attending K to Grade 3. However, in order to be entitled to the subsidy from the Danish Government, CIS is obliged to separately invoice a part of our Tuition as an “SFO Fee”. Thus it is not an extra fee but an integral part of our Tuition Fee and as such should be covered by your company. If you have any questions in this regard please contact the business office.</p>
<p><b>LATE ARRIVERS</b></p>	<p>If joining the school during the school year below payment terms applies:</p> <ul style="list-style-type: none"> <li>• If joining before 12. October full tuition is paid.</li> <li>• If joining between 21. October and 13. December 75% of yearly tuition is paid.</li> <li>• If joining 7. January- 3. April 50% of yearly tuition is paid.</li> <li>• If joining after 13. April 25% of yearly tuition is paid.</li> </ul> <p>After a place has been offered and accepted a payment of minimum of 25% of the annual Tuition Fee has to be paid within 8 days.</p>
<p><b>EARLY LEAVERS</b></p>	<p><b>Withdrawing before start of school year:</b></p> <ul style="list-style-type: none"> <li>• Re-enrolled and withdrawing for next school year after 6. May 2019 but before 1. June 2019 means obligation to pay 1 month tuition.</li> <li>• Withdrawing after 3. June 2019 means obligation to pay 25% of next school year tuition as seat has been reserved.</li> </ul> <p>If leaving the school <b>during the school year</b> below payment terms applies:</p> <ul style="list-style-type: none"> <li>• If leaving before 12. October 75% of tuition is refunded.</li> <li>• If leaving between 21. October and 14. December 50% of yearly tuition is refunded.</li> <li>• If leaving between 7. January- 4. April 25% of yearly tuition is refunded.</li> <li>• If leaving after 14. April no tuition is refunded.</li> </ul> <p><b>2 month notice must always be given prior to the above deadline intervals</b> to get part of tuition refunded. Notice must be given by submitting the <b>“Withdrawal form”</b>.</p>
